Dear members, dear friends,

As we turn the page on 2022, it is time to reflect on the year's developments. Over the year, SGI Europe and its members, providers of services of general interest across the EU, have navigated **numerous unanticipated challenges**. While the EU was getting back on its feet following the **COVID-19 pandemic**, the unjustified **Russian war of aggression on Ukraine** presented new challenges. In the face of those emerging difficulties, the **EU and providers of services of general interest have seized the opportunity to reinforce their sustainable development and growth further**.

2022 was therefore a year marked by **adaptability and innovation**. Despite the lingering impacts of the COVID-19 pandemic, **enterprises of services of general interest continued to evolve, responding swiftly to the shifting needs and demands**. While they were tested by circumstances, our members stood up to the challenge to bring up innovative solutions and continue serving customers – citizens and businesses – **contributing to the ongoing recovery efforts and societal resilience**.

With the support of our members, SGI Europe continued to actively engage with EU policymakers, advocating for **growth, sustainability, and fair competition**. Through our international network and with our national partners, we joined critical discussions and contributed to the long-term transformation of the EU economy. Our involvement in the **Conference on the Future of Europe, in which SGI Europe spearheaded the contribution of the EU social partners, is a perfect example of the difference we can make**.

Throughout the year, and as the EU took a radical turn to divest from Russian oil and embrace renewable energy, **SGI Europe remained committed to addressing the climate change challenges**. Recognising the urgency and gravity of the situation, our association have undertaken initiatives to promote sustainable growth

and advance the transition towards a low-carbon economy. Amongst others, **SGI Europe continued to play a key role in developing and implementing the EU Sustainable Finance Framework and the EU Taxonomy**.

We cannot reflect on 2022 without acknowledging the profound consequences of the war in Ukraine. The conflict had a significant impact on our **energy systems and our economy**. In the face of the uncertainty accompanying the conflict, SGI Europe and its members **engaged with Ukrainian counterparts, supporting them in continuing their missions and in their fight for freedom**.

Despite those challenges, SGI Europe continued solidifying its centrality at the EU level. The renewed **focus on affordability, accessibility and quality of essential services, as well as the emerging discussions on the resilience of critical infrastructures, led to increased attention on SGIs**. Both as providers of essential services and as representatives, at cross-sectoral level, of employers and providers of services of general interest, **SGI Europe has continued throughout 2022 to consolidate its key relationships with EU decision-makers and leaders**.

While 2023 should be a year of transition, the EU elections in 2024 will mark the beginning of a new chapter for EU construction. The implementation of the EU Green Deal, the return to economic growth and the continued operations of SGIs are key challenges. While they may be daunting, we are confident that SGI Europe and its members will overcome them together. **By fostering cooperation, sharing best practices, embracing innovation and proposing pragmatic compromises emerging from the diversity of our membership, we will continue to drive progress, sustainable growth, and a brighter future**.

What is SGI Europe?



SGI Europe (formerly CEEP, the European Centre of Employers and Enterprises providing Public Services and Services of general interest) **represents employers and enterprises providing services of general interest (SGIs)** since 1961. Our members are organisations active in fields such as:

- Central & local administrations,
- Healthcare,
- Education,
- Social services,
- Housing,
- Waste management,
- Energy,
- Transport,
- Water,
- Environment,
- Communications.

Modern services of general interest (SGIs) serve the fundamental goals of the EU, **supporting business, social and territorial cohesion, economic and social solidarity, and a better quality of life for all citizens**.

Present at the heart of the EU

Along with BusinessEurope and ETUC, SGI Europe is **one of the three European general cross-industry social partners**. SGI Europe is an actor in the **EU social dialogue**, having a voice in the European **bipartite** – negotiating with trade unions – **and tripartite** – with social partners and representatives of the EU institutions – social dialogue at the highest level.

Lobbying for Services of General Interest

SGI Europe, with its general secretariat in Brussels, represents the interests of its members before the European institutions. We lobby the European Commission, the European Council, and the European Parliament regularly on **any legislative proposal impacting and affecting SGIs and their place in the single market**.

Advocating the Importance of SGIs

SGI Europe also carries out projects promoting the **importance of modern services and SGIs in Europe**. Whether supported by the European Commission or carried out independently, SGI Europe brings a new light on services of general interest, their modernisation and their central role in citizens' lives.

2022 in Review

In 2022, Europe faced several significant challenges. The Russian war of invasion in Ukraine brought war back in Europe, with ripple effects impacting the daily lives of EU citizens. On top of that, the COVID-19 pandemic continued to impact the continent, with new variants causing more infections and public health measures. The economic recovery, which looked promising in 2021, stalled as a consequence of increasing geopolitical tensions. Climate change and environmental issues also gained further prominence, with extreme weather events developing across the EU and calling for urgent answers to bring the life the Sustainable Development Goals. Europe grappled with these new challenges, striving for solutions to ensure stability, prosperity, and resilience.

The war in Ukraine and its impact on the EU

In 2022, the EU witnessed in its immediate neighbourhood significant events and developments which were unimaginable a few years ago. Russia launched a full-scale invasion of Ukraine, leading to dramatic consequences for an EU economy, which was starting to recover from the COVID-19 pandemic. In particular, the war dramatically impacted energy prices and inflation.

Started in 2014, the conflict in Ukraine escalated in 2022. In February, Russia launched a full-scale invasion of Ukraine, prompting international condemnation and concern. The war had severe humanitarian consequences, causing the displacement of millions of people, thousands of deaths and massive destruction throughout Ukraine.

The conflict also had profound economic implications, especially for the EU, which heavily relies on Russian natural gas supplies. As Russia's actions in Ukraine intensified, the EU faced a significant gas supply crisis. Russia being the largest supplier of natural gas to the EU, gas flows were reduced and even halted gas between the EU and Russia, causing energy prices to skyrocket. EU Member States were forced to tap into their strategic reserves and explored alternative energy suppliers and sources to mitigate the impact.

The surge in energy prices had far-reaching consequences for the EU economy, causing historically high inflation across the 27. Energy-intensive industries faced higher costs, which affected their competitiveness. Enterprises of services of general interest also faced increased pressures, stuck between the need to continue to provide affordable and high-quality SGIs, higher costs to continue operating, and users struggling to pay as the overall cost of living for EU citizens increased, contributing to inflationary pressures.

To address the energy crisis, the EU further accelerated the net-zero transition, focusing on boosting renewables. Through the REPowerEU, investments in wind, solar, and other renewable technologies were ramped up to reduce dependence on fossil fuels and enhance the security of supply. Additionally, the EU sought to diversify energy imports by exploring new partnerships and supply routes.

While the energy crisis dominated the economic landscape, the EU implemented various measures to stabilise its economy and support member states affected by the conflict. Amongst others, the European Central Bank maintained accommodative monetary policies to stimulate growth and counter inflationary pressures. Fiscal stimulus packages were also rolled out to support affected industries and promote economic recovery. At the same time, the temporary framework for state aid, initially set up during the COVID-19 pandemic, was transformed to fit the needs and new circumstances better.

Both as social partners and as providers of services of general interest, SGI Europe contributed to the EU response. Through our support to the Ukrainian people, our activities towards EU institutions at the highest level, and our technical contributions on the Fit-for-55 and the REPowerEU, SGI providers and employers have highlighted vital challenges, identified relevant areas of actions and continued to put forward a pragmatic approach, balancing immediate emergencies with the long-term perspective.

The Conference on the Future of Europe

The Conference on the Future of Europe (CoFoE) was a proposal of the European Commission and the European Parliament, announced at the end of 2019, to look at the medium to long-term future of the EU and what reforms should be made to its policies and institutions. The CoFoE involved citizens, social partners, civil society and European institutions.

The CoFoE officially started on 9 May 2021, on Europe Day, with the inaugural plenary. As an EU social partner, SGI Europe was represented in the plenary by Pascal Bolo, President (in the Working Group on Climate Change and Environment) and Valeria Ronzitti, General Secretary (nominated in the Plenary Working Group on Health). President Bolo and General Secretary Ronzitti represented SGI Europe every step of the way to identify and highlight areas of improvement for EU actions, including during the six plenary sessions organised, as well as the opening and closing sessions and the feedback event in December 2022.

SGI Europe also contributed to the Digital Platform set up in the context of the CoFoE and shared key ideas to shape a green, fair and digital Europe moving forward. Those contributions focused on the following dimensions at the heart of the work of SGI Europe:

- A Fair and Social Europe
- The Future of the EU Green Deal
- The digitalisation of the EU economy
- SGI Europe's position on Health reforms in the context of the Conference of the Future of Europe

SGI Europe also joined forces with its partners, such as the EU social partners (ETUC, BusinessEurope, SMEUnited), the European Movement International, and the Employers' group of the European Economic and Social Committee.

Finally, SGI Europe also organised dedicated events in this context to feed and encourage the exchanges between its members, EU and national institutions, and external stakeholders. Amongst others, the following dedicated events were organised by SGI Europe, jointly with our members:

- **5 November 2021: SGI Europe - ETUC event on the Conference on the Future of Europe (CoFoE), organised in Lisbon (Portugal)**, with, amongst others, Ana Mendes Godinho, Portuguese Minister of Labour, Solidarity and Social Security, Regina Bastos, PT CoFoE National Coordinator, Liina Carr, ETUC Confederal Secretary, and Luis Natal Marques, SGI Portugal President.
- **4 May 2022: Panel on the Conference on the Future of Europe, in the context of the Festival "Health and Safety at Work" of Fondazione Rubes Triva in Urbino (Italy)**, with, amongst others, Maroš Šefcovic, European Commission Vice-President for Interinstitutional Relations and Foresight, and Benedetto Della Vedova, Undersecretary of State of the Italian Ministry of foreign affairs.

With the Conference on the Future of Europe, the EU has completed a historical exercise of participatory democracy. Bringing together institutions, citizens, social partners and civil society, it provided feedback on our joint actions and should lead to improving our joint project. Building upon its activities throughout the process, SGI Europe now calls on the EU institutions to deliver on the expectations highlighted by citizens, social partners and civil society and bring to life the final report of the Conference on the Future of Europe.

SGI Europe joins the OECD Global Deal

On 15 December 2022, **SGI Europe joined the Global Deal, an OECD-led multi-stakeholder partnership of governments, businesses and employers' organisations, trade unions, civil society and other organisations which aimed at promoting social dialogue** and sound industrial relations as effective means for achieving decent work and inclusive growth. SGI Europe is the **first employers' association of the EU cross-industry social dialogue to join the Global Deal**.

It enables knowledge sharing, facilitates policy discussions, strengthens the capacity of partners to engage in dialogue, and produces evidence-based research. As a unique action-oriented platform, the Global Deal accelerates positive change by encouraging partners to make voluntary commitments to advance social dialogue.

As part of its first commitment to the Global Deal, SGI Europe will continue its efforts to support the EU social dialogue in line with the priorities identified by the EU Social Partners in their Work Programme 2022-24, including the review and update of the 2002 Autonomous Agreement on Telework with the views of transforming it into a directive. SGI Europe will also strengthen the capacity of its members to engage in social dialogue at the national level through training and knowledge-sharing.

As part of a second commitment, SGI Europe will further promote a fair green transition, especially in the context of the EU Year of Skills in 2023. The road to a low-carbon economy will significantly impact the type

of skills demanded by labour markets. Consequently, SGI Europe will address skills mismatches and identify pathways to improve the provision of vocational education and training (VET), focusing on emerging green skills. As a landmark of its pledge, SGI Europe conducted the Green Skills in VET project to promote better cooperation between SGI providers and VET institutions.

Before joining the partnership, on 2 November 2022, **SGI Europe addressed the 2022 Global Deal Forum in Madrid**. As a primary annual event on social dialogue bringing together high-level representatives from governments, employers' organisations, trade unions and other stakeholders, the Global Deal explored the importance of social dialogue in **shaping a just transition and managing non-standard employment forms. In 2022, the Forum focused on ensuring a just transition through social dialogue**.

Valeria Ronzitti, SGI Europe's General Secretary, joined Carina Cabezas (President, Sodexo Iberia), Luis Miguel de Camps Garcia-Mella (Minister of Labour, Dominican Republic), Boitumelo Moloi (Deputy Minister of Employment and Labour, South Africa), Stephen Cotton (General Secretary, International Transport Workers' Federation), Luis Rodrigo Morales (Senior Advisor, International Organisation of Employers) to discuss **"Social dialogue for the greening of the Economy in times of crisis"**, in a discussion moderated by Stefano Scarpetta (Director Employment, Labour and Social Affairs, OECD).

The values of SGIs and exchanges of practices at the heart SGI Europe's study visit in Nantes

In June 2022, SGI Europe – France and Nantes-Métropole hosted the statutory meetings of SGI Europe. Meetings and side events were organised in this context by SGI Europe members from the area (including EDF and Semitan, Nantes' public transport company) and their local partners (including La Maison de l'Europe). They were a golden opportunity to recall the values at the heart of employers and providers of services of general interest: inclusiveness, green and innovation.

On top of the statutory meetings, several side activities were on the agenda:

Conference "European Union: a job for every young person?"

Focusing on the role of SGI as employers, a dedicated event, "European Union: a job for every young person?" (organised by La Maison de l'Europe), provided a unique platform to discuss youth policies and, more specifically, the role of SGIs in supporting inclusiveness and youth employment. On this occasion, SGI Europe's Presidential Team – President Pascal Bolo and Vice-Presidents Milena Angelova, Filippo Brandolini and Ingbert Liebing – presented the challenges, solutions and opportunities from their respective countries, addressing, amongst others, the emergence of new jobs, skills mismatches, the need for adapting training schemes and the role of social dialogue.

Discovery tour of Nantes with Semitan

Bridging inclusiveness and green policies, public transport enterprises connect neighbourhoods and support social and economic development while providing the best strategy to decarbonise urban transport. In Nantes, the Semitan (Société d'économie mixte des transports en commun de l'agglomération nantaise) is the local public transport operator, with buses, trams and water buses in operation.

Semitan has consistently been recognised as an innovative enterprise. In 1985, Nantes was one of the first cities in France to launch a modern tramway network, which now covers more the 40 kilometres of tram lines. More recently, Nantes launched in 2006 a dedicated "Busway" system, a dedicated rapid transit line with high frequency and high capacity. The Busway was further modernised in 2019 with the first e-Busway, a new generation of longer e-bus with ultra-fast charging capacity.

Pioneering in using electrified tramway services and high-capacity e-buses, Semitan and Nantes have put innovation and creativity to the benefit of high-quality, low-carbon mobility for citizens.

Visit of the EDF nuclear plant in Chinon

On Thursday 9 June, a small delegation of SGI Europe members visited the nuclear plant of Chinon (located 130 kilometres east of Nantes), organised by EDF. This visit was a unique opportunity to discover the full potential of nuclear in the decarbonisation of electricity production and its contribution to the energy transition. Employing 2,246 employees, producing 6% of the French nuclear power and emitting 12g CO₂/KWh over the entire life cycle of the plant, the Chinon nuclear plant has been, since its construction in the 1960s and its modernisation in the 1980s, one of the vital economic enablers of growth of Western France. Participants in the visit were provided with a full tour, discovering the different phases and steps of safe nuclear power production, from nuclear fission to electricity production.

Projects



SGI Europe CSR Label

The 8th edition of the SGI Europe CSR Label was concluded in February 2022. **As the only EU label for services of general interest (SGIs), the SGI Europe CSR Label has rewarded over 150 enterprises for their outstanding Corporate Social Responsibility activities since its creation in 2008.** The SGI Europe CSR Label is proof that social responsibility is a matter for all companies: public service companies of all sizes are champions in this field.

On 23 February 2022, SGI Europe organised the 8th awarding ceremony of its CSR Label, hosted in Paris by Electricité de France (EDF). Nineteen enterprises of services of general interest from across Europe were awarded for their CSR practices after completing the evaluation steps. Ahead of the awarding ceremony, SGI Europe also organised a **dedicated workshop on implementing the EU Taxonomy Regulation, highlighting the intention to create a new generation of CSR labels for SGIs focusing on the EU Taxonomy.**

SGI Europe Projects

Green Skills in VET

In 2021 and 2022, SGI Europe and the European Federation of Education Employers (EFEE) conducted a joint EU project, “Green Skills in VET”, co-financed by the European Commission. The project aims to support SGIs and vocational education and training (VET) providers to **identify skills, develop skills intelligence and adapt trainings to succeed in the green transition.**

The project focused on three key SGI sectors directly at the heart of the transition: water, transport, and energy. The objectives were three-fold:

- **Identifying the current demands for green skills and jobs** in the three sectors and the single out any mismatch between skills needs and learning provision;
- **Promoting and sharing teaching and training methods** between the education and training supply and the SGIs to align these two sectors as much as possible;
- **Adapting the professional development of VET staff and designing solutions for enterprises** and education providers for adapting green skills delivery.

Building upon the success of the kick-off conference and the first workshop organised in 2021, SGI Europe and EFEE conducted the following events in 2022:

- **1 February 2022: Second sectoral workshop** of the project Green Skills in VET (on the energy sector)
- **24 May 2022: Third sectoral workshop** of the project Green Skills in VET (on the transport sector)
- **5 December 2022: Dissemination conference**

During the dissemination conference of the project, the primary outcomes were presented and discussed by EU decision-makers, including **Nicolas Schmit**, European Commissioner for Jobs and Social Rights, **Stefan Olsson**, Deputy Director-General at the European Commission’s DG Employment, VET and SGI providers such as **Union Française de l’Energie**, **MBO Raad** and **Escuela del Agua de Agbar** and experts **from CEDEFOP and ADAPT** (subcontracted experts for the projects).

The final reports were also presented, offering key policy recommendations to different stakeholders, including the European Commission, Member States, national and EU social partners, and VET providers, focusing on **promoting the strategic role of VET in meeting the objectives of the EU Green Deal, modernising skills strategies and training programs, and using social dialogue to boost sustainable development.** The project outcomes will continuously be disseminated, especially in line with activities carried out in the context of the EU Year of Skills throughout 2023.



Involving SGIs in the European Semester

Co-financed by the European Commission, SGI Europe’s project “Involving SGIs in the European Semester” also concluded in 2022. It led to **upgrading the current involvement of SGI Europe members** (and providers of SGIs in general) in the European Semester with a more **straightforward methodology and increased coordination amongst our members.**

As SGI employers are becoming essential in the EU economy and deliver on environmental sustainability, productivity gains, fairness and macro-economic stability, this project has **developed the capacity for SGI employers to design tools and consultation methods to provide high-quality inputs to the reform process in Europe.**

Together with its project partners – Swedish Association of Local Authorities and Regions (SALAR, Sweden), Union of Social and Solidarity Economy Employers (UDES, France), and the Union of Social Profit Companies (UNISOC, Belgium), SGI Europe contributed to:

- **Identify several challenges for the effective involvement in the European Semester of SGI Europe members**, including improving the knowledge of the Semester process and its mechanisms, as well as explaining the expectations about the contributions SGI Europe members expected;
- **Bring forward best practices through which SGI Europe members are involved** in different stages of consultations, and discuss how those could be replicated;
- **Provide an overview of the Semester process and highlight how SGI Europe members can engage** in the process based on a thematic analysis of the Semester process based on SGI Europe’s policy priorities;

Offer key recommendations for SGI providers, focusing on organising training and awareness-raising activities, engaging with the main stakeholders coordinating the Semester process in each Member State, and using the Semester process more actively to ensure their views are heard by the national government in adopting key reforms. Three thematic workshops were organised in the framework of this project in 2022:

- **24 February 2022, in Paris (France), hosted by UDES;**
- **3 May 2022, in Stockholm (Sweden), hosted by SALAR;**
- **6 July 2022, in Warsaw (Poland), hosted by Employers of Poland.**

SGI Europe organised on **8 December** the **final conference of the project** ‘Involving SGIs in the European Semester’, co-funded by the European Commission. On this occasion, the project’s final report was published and is available. A political report is also available in English, French, German, Polish, and Bulgarian. This study was carried out by researcher Inga Pavlovaite as a subcontractor.

Held on 8 December 2022, the final conference of the project featured a **keynote opening by Valdis Dombrovskis**, European Commission Executive Vice-President, and an **introduction by Pascal Bolo**, SGI Europe President, as well as the presentation of the project’s methodology. Two roundtable discussions then allowed SGI Europe members involved in the project to present the state of play of the national dimensions of the EU Semester.

Work Programme of the Social Partners for 2022-2024 and the revision of the autonomous agreement on telework

SGI Europe, the European Trade Union Confederation, BusinessEurope and SMEunited concluded the negotiations on the new Social Partners' Work Programme for 2022-2024 on Friday 18 March 2022. The outcomes were presented to EU leaders at the Tripartite Social Summit on 23 March and were the central element of the social partners' conference on social dialogue on 28 June.

The work programme for the period 2022-2024 is giving social partners a **central role in the green and digital transformation of the EU economy**, as it includes new initiatives to ensure social partners actively contribute to economic and social progress. SGI Europe negotiating team was **instrumental in reaching an agreement, with the Social Affairs Board closely monitoring the negotiation process.**

The **six priorities identified in the work programme for 2022-2024 are the following:**

- Telework and right to disconnect
- Green Transition
- Youth Employment
- Work-related privacy and surveillance
- Improving skills matching in Europe
- Capacity building

The EU Social partners agreed, in particular, to **revise their first autonomous agreement from 2002 on Telework and to include to it the right to disconnect.** The social partners also agreed to send the result of this negotiation to the European Commission with a view to **translating it into a directive, according to the social partners' prerogatives entailed in Article 154 of the Treaty on the Functioning of the European Union.**

This legislative approach to EU social dialogue also **sends a clear and essential signal to European institutions about the cooperation and ambition of the social partners at the EU level.** It also secures the ownership of social partners in a context where the European Parliament and the Commission are showing more and more interest in legislating on social issues. SGI Europe's Social Affairs Board subsequently elaborated its mandate for the negotiations, which was adopted in time for a high-level conference on social dialogue on 28 June.

The negotiation on telework and the right to disconnect started with a fact-finding seminar in October 2022, taking stock of the situation at the national level. The negotiations officially began in November 2022, with the view of finalising it in 2023.

Contribution to shaping the European Commission's initiative on social dialogue

As announced in the communication accompanying the Commission Work Programme 2022 unveiled on 19 October 2021, the **Commission started in 2022 a series of consultations with the social partners to produce a package dedicated to strengthening social dialogue and comprising a communication and a proposal for a Council Recommendation.** This process was the direct continuation of the 2016 "new start for social dialogue", agreed upon by the EU cross-sectoral social partners, the European Commission and the Dutch presidency of the Council of the EU.

The new social dialogue initiative aims at **strengthening social dialogue at the EU and national levels to support the critical role of social partners in fostering a fair economic and social recovery** and the green, digital and labour market transitions. SGI Europe played a crucial part, from the initiative's inception to its content's delimitation.

The European Commission involved social partners very closely in preparing the social dialogue initiative. As such, SGI Europe's Social Affairs Board was consulted at various stages through ad-hoc or regular meetings. In

the context of preparing both the communication and proposal for a Council recommendation, **two dedicated hearings were organised in April and May 2022, bringing together employers and trade unions from the national level and including a delegation of SGI Europe's members.** Another dedicated consultation was held on the supporting framework for social partner agreements, which took place in March 2022.

These consultations, including directly members, were followed by high-level meetings between EU social partners general secretaries and Nicolas Schmit, European Commissioner for Jobs and Social Rights, to actively shape the recommendation before its publication.

Involving members of the Social Affairs Board from its launch, this process was very successful. It ensured that the **work of social partners at the EU and national levels is now supported by well-shaped instruments, guaranteeing their reinforced involvement in policymaking.** Building on 12 months of consultations, the social dialogue initiative was published in January 2023.

Organisation of the meeting of the Social Affairs Board in Hamburg - September 2022

At the kind invitation of SAB Vice-chair Urban Siebert, SGI Europe organised the meeting of its Social Affairs Board of 26 September 2022 in the beautiful city of Hamburg, Germany, in the offices the *Arbeitsrechtliche Vereinigung Hamburg e.V.* (AVH).

Members of the Social Affairs Board met on this occasion to discuss the start of the cross-sectoral social partners negotiations on telework and a right to disconnect. They exchanged on the priorities for SGI Europe - both as employers and providers of SGIs - in line with the agreed mandate for the negotiations, and discussed the national regulatory regimes for telework, as well as the national legislations and collective agreements on a right to disconnect.

The members also agreed during their meeting in Hamburg on the SGI Europe position paper on the European Commission proposal for a directive on working conditions for platform work.

Management of the energy crisis and the REPowerEU plan

Following the Russian invasion of Ukraine and responding to the need to reduce its dependency on Russian oil and gas, the European Commission presented in March a new energy strategy, which was concretely proposed in May 2022 as the **REPowerEU plan, focusing on three pillars: save energy, produce clean energy, and diversify energy supplies.**

SGI Europe welcomed the principles of the proposed REPowerEU initiative, especially the **attention given to the security of supply, energy efficiency, the roll-out of renewables and the decarbonisation by electrification and hydrogen.** SGI Europe highlighted that the climate targets would only be achieved if all sectors and instruments contribute to a common goal. This means fostering direct and indirect electrification based on renewables and low-carbon energy sources while safeguarding the vital role of biogases and other renewable and recovered energy sources, like energy from waste management. It will be **essential to consider the maturity of all technologies, applying technology neutrality and robust CO2 prices.**

Three key measures must be respected to overcome the crisis and achieve Europe's future climate and energy transition. In the short term, measures must be based on **demand reduction, joint procurement of EU gas purchases and guaranteeing energy at stable costs** (including through targeted forms of compensation for end-users). However, SGI Europe recalled that an overall price ceiling on the gas market should only be considered in exceptional situations and be accompanied by a mechanism to maintain supplies subject to international competition, particularly LNG.

In the medium term, **reinforcing the security of supply must be the priority to ensure sustainability and affordability by optimising the use of available resources within the EU.** Electricity and decarbonised

and renewable gases, such as hydrogen, are the final energy carriers of the energy transition towards a fully decarbonised EU.

In the long-term, **implementing the EU Green Deal must remain the way forward,** emphasising its increased ambition while allowing for flexibility and technology neutrality. On the financial side, it is necessary to set **schemes into motion to enable the huge investments we face to accelerate the EU race out of fossil fuels.**

All these investments in sustainable energy technologies are massive and require a **stable and long-term enabling framework giving more visibility to investors.** It is now time to rethink this framework for investment, especially in the electricity market, which is the core element of the EU energy transition. Long-term investments in emerging technologies, such as hydrogen, should benefit from innovative investments arrangement. This also includes **mixing subsidy schemes from European, national, regional and local levels.** Reducing investors' risks is critical and goes through more long-term arrangements.

SGI Europe also actively **promotes an increase and acceleration in the provision of new training schemes built on the needs identified by social partners.** Employers and providers of SGIs need to be given the right framework to ensure the transition is just for the workers they employ and the citizens they serve. The transitional pathways must offer workers quality jobs and provide financing incentives and solutions for citizens. As part of the Fit-for-55 package, the **Social Climate Fund must deliver essential support now and ensure its implementation effectively reaches its intended objectives.**



SGI Europe event on "From Low to Zero Emission: How to decarbonise urban and peri-urban mobility?", organised with our members EDF and Transdev

SGI Europe event "From Low to Zero Emission: How to decarbonise urban and peri-urban mobility?"

On 15 June 2022, **SGI Europe, with the support of its members EDF and Transdev, organised a conference,** "From Low to Zero Emission: How to decarbonise urban and peri-urban mobility? An Alliance between Energy and Transport". Addressing the need to decarbonise urban and peri-urban mobility to achieve EU's climate neutrality by 2050, the conference brought together **EU decision-makers, transport and energy providers to address the relationship between the different sectors, with the transition towards zero-emission mobility as a critical goal.**

Split into two panels and moderated by Lucie Petersen (EU Policy Expert, UITP), the event welcomed on this occasion MEP Ismail Ertug (S&D, DE), Dario Dubolino (Sustainable & Intelligent Transport, European Commission), Antoine Grange (CEO Europe, Transdev), Jörn Schwarze (Kölner Verkehrs-Betriebe AG), Julien Martin (Head of Regulation Mobility Department, EDF), Jens Müller (Policy and Research Lead, Transport & Environment) and Michael Villa (Executive Director, SmartEn) and Elisa Schenner (Head of Brussels Office, Wiener Stadtwerke GmbH).

Services of general interest cover a broad scope of sectors directly at the heart of the decarbonisation, making SGI Europe a central stakeholder in articulating ideas and messages towards EU institutions. Valeria Ronzitti, SGI Europe General Secretary, also underscored the high level of investments needed to achieve the EU's decarbonisation objectives and mobilise the EU Taxonomy to bring resources from the private sector into sustainable activities. Finally, she recalled that the high benefits derived from using data must be proportional to the costs of making them available.

Panel 1: How to decarbonise urban and peri-urban mobility?

Speakers in the first panel focused on the challenges of the decarbonisation of urban and peri-urban mobility, including the financing of the charging infrastructures, the appropriateness of the EU legal framework, and balancing the climate ambitions with the challenges and needs of public transport providers. Opened by MEP Ismail Ertug, the implementation of the Fit-for-55 (FF55) package, especially the Alternative Fuels Infrastructure Regulation (AFIR, for which he was rapporteur at the European Parliament), was at the heart of the discussions, with a specific focus on the investment needs stemming from the ongoing electrification of the transport sector.

Panel 2: An Alliance between Energy and Transport

The second panel discussed the need for a genuine alliance and cooperation between the energy and transport sectors and how to reinforce existing synergies, expanding already beyond those sectors (and including also, for instance, the housing sector and the recharging infrastructures). The transformational power of digitalisation and the data economy was also highlighted, especially for public transport operators. Pre-requisite to succeed in this twin transition, answering the investment challenge for public transport and SGI providers to produce non-existing data, make them usable and interoperable, and frequently monitor and report them will be of prime importance. However, public transport must remain the best e-mobility and decarbonisation policy for the city, calling for investment in public transport to give back the city to citizens.

State aid: Shifting from enforcement of competition to shaping policies

Since the years of unprecedented events, from the outbreak of COVID-19 to the energy crisis and the war in Ukraine, state aid control has gained further prominence in recent years. With a phase-out of the COVID-19 Temporary State Aid Framework in 2022, which had only little relevance for providers of services of general interest (as they never ceased operations during the pandemic), the **PSB actively monitored the introduction of the new Temporary Crisis and Transition Framework, put in place in March 2022 and aimed at remedying the economic downturn due to high energy prices.**

In 2022, the framework was amended twice, with further simplifications of calculations of aid and adaptations of aid thresholds and intensities, which allowed for mitigating liquidity problems due to the high energy prices. As the first versions of the Temporary Crisis and Transition Framework focused on energy-intensive industries, the second amendment emphasised that the **energy transition would be the only way to overcome the dependency on Russian energy.** A significant shift in state aid was introduced, as in the TCF as a tool to respond to the acute crisis, provisions were added to promote the green transition further.

SGI Europe also worked on the **revision of other state aid guidelines.** Since many of SGI Europe's members are either broadband providers or utilities sharing the infrastructures, the revision of the guidelines on state aid for broadband networks was of great importance. SGI Europe responded to the consultation on 11 February 2022, **calling for a clear prioritisation of gigabit fixed networks, protection of physical assets, information and data of critical infrastructure when operators participate in a competitive selection procedure.**

In 2022, the Public Services Board also worked with the Transport Task Force to revise the **non-paper interpretative guidelines for Regulation 1370/2007** (on public passenger transport services by rail and road). Regulation 1370/2007 is a crucial legislation for compensating public service obligations in the transport sector. On 10 February, SGI Europe responded to the targeted public consultation to revise the non-paper interpretative guidelines for Regulation 1370/2007, expressing concerns about the new demands to fulfil the first Altmark criterion. Additionally, SGI Europe exchanged with the European Commission, specifically the Unit on the Legal Issues and Enforcement Unit within the Directorate-General for Mobility & Transport (DG MOVE).

Data Policy

In recent years, the European Commission has put an increased focus on **developing a European Strategy for data.** As data is becoming an essential resource for economic growth, competitiveness, innovation, job creation and societal progress in general, the EU aims to **create a single market for data to ensure Europe's global competitiveness and data sovereignty.** For SGIs, data can be a powerful tool to understand the users' needs better and consequently improve the services' quality. However, the **collection and management of data require significant investments, which must be considered when designing the future of the EU data space.**

In that context, on 13 May, SGI Europe responded to the **Commission's proposal for a Data Act.** SGI Europe welcomed the proposal as an appropriate instrument to stimulate the development of a market for data from competitive connected objects and innovation based on this data. At the same time, **SGI Europe was more cautious about the precision of the definitions.**

In the context of the meeting of the Public Services Board on 7 July 2022, **SGI Europe also exchanged on the Data Act with the representative from European Commission's Directorate General for Communications Networks, Content and Technology.**

Another essential file regarding data policy was the **implementing act on high-value datasets and on the availability of public data sets.** This implementing act complements the Open Data Directive (formerly Public Sector Information (PSI) Directive), which obliges the public sector to make data available. SGI Europe called for less burdensome solutions to ensure the availability and usability of datasets, in line with the directive's provisions. **Encouraging synergies and cooperation between local, regional and national public sector bodies and institutions should be better supported to create economies of scale and prevent redundancies in formatting and making available datasets.** Such increased cooperation between the different levels would allow for the key provisions of the Open Data Directive to be met whilst minimising the burden on individual public bodies and institutions.
